



Treehouse Travel Terms and Conditions

1. **PERSONAL DATA:** I have reviewed the reservation made on my behalf by Treehouse Travel including, but not limited to, the names matching exactly to government-issued photo ID, birthdates, and dates of travel and I agree that they are correct. I acknowledge that my failure to provide correct information may result in monetary penalties to make necessary reservation changes, an undue delay at airport security, or denied boarding.
2. **CANCELLATION PENALTIES:** I understand that Treehouse Travel is not responsible for any cancellation by me, errors or omissions on my behalf, or cancellation by vendors providing travel services as a result of this reservation. I have read and understand the amendment and cancellation policies of the vendor's travel program that I have purchased. I agree to pay all charges, fees, and penalties, and hereby hold Treehouse Travel harmless and free of any claims made as a result of the changes or cancellation to this travel reservation. In addition, Treehouse Travel has the right to impose a fee of \$100pp for any change or cancellation made by me after deposit which will be collected using the card on file before the change or cancellation is processed.
3. **DOCUMENTATION:** I acknowledge that travel documentation appropriate for entry to my itinerary destination(s), such as passports, visas, and inoculation certificates, remain my responsibility. I understand that if I do not meet advised health and entry requirements or do not present the proper identification, I will be denied boarding and will forfeit all trip monies. **Valid passports are required for ALL international destinations. If a passport is required to travel to your destination, the expiration date must be at least six (6) months following the return date of the planned travel.** Each foreign country holds different views of past criminal offenses. IF you have a current or past criminal offense (including DUI records or unpaid child support), please contact that country directly for entry and exit requirements. 4. **INHERENT RISK:** I understand that travel to many parts of the world has an inherent risk of exposure to a variety of hazards to my health and/or safety, including but not limited to disease, crime, terrorism/warfare, and severe weather conditions. I accept responsibility for researching the safety of the destination, as well as the areas I'm traveling through, and will rely solely on that information to decide whether to travel based on my personal risk tolerance. Examples of reputable sources for travel advisories include the CDC and the US State Department. Because each traveler's risk tolerance is different, Treehouse Travel is not in a position to advise whether I should travel to any destination at any particular time.
5. **DOT DISCLAIMER:** The Department of Transportation requires this legal disclaimer: *The travel products and services being purchased may be subject to additional surcharges, cost increases, and fees imposed by the individual travel suppliers or government entities after the purchase date. I understand that I may be charged these post-purchase amounts for reasons varying from currency exchange fluctuations, fuel surcharges, or new travel taxes. I consent to these price increases and authorize the charges on my credit card for these amounts.*
6. **PRICING:** Price quotes are applicable only to the date and time at which they are provided. Quotes in foreign currency are subject to fluctuations in exchange rates and international credit card issuer fees. Treehouse Travel has made every effort to make you aware of all fees and surcharges to be paid outside of this confirmation but is not responsible for any direct fees charged by the travel supplier that it is not aware of or that is subject to change.
7. **DEPARTURE RESPONSIBILITIES:** If flying, it is recommended that you arrive at the airport early, as instructed by your airline. However, recommended check-in times are subject to change without notification. I acknowledge that it is my responsibility to reconfirm flight times at least 24-72 hours prior to scheduled departure and to remain abreast of changes in condition, schedule, security procedures, or airport rules that might require different airport arrival times.
8. **LIMITS OF LIABILITY:** Treehouse Travel is not the source or supplier of the travel services requested and acts solely as a booking agent for disclosed supplier cruise lines, hotels, airlines, ground transportation, and other companies providing accommodations, transportation, and/or other services. Each of these suppliers is an independent entity with its own management and Treehouse Travel is not responsible for their acts or omissions. Treehouse Travel is compensated through commission and fees from the travel supplier(s) and is not liable for damages above this amount. If I attempt to dispute any charge with my credit card company (a "chargeback") that meets the terms and conditions of the travel supplier and the terms of this contract, Treehouse Travel will be entitled to full recovery, including reasonable attorneys' fees and court costs, for collection of these funds.
9. **TRAVEL INSURANCE:** Travel protection is recommended by Treehouse Travel to protect clients from many situations that could cause this trip to be canceled, interrupted, or delayed resulting in a loss of time and monies. I agree to hold Treehouse Travel harmless for any denial of claim by travel insurer or any expenses incurred by my election to not purchase a travel protection plan.
